As the judge's decision in the following classes is based on the merits of more than one dog or bitch, no one of the dogs or bitches judged first in these classes will be eligible to compete for Best of Breed by virtue of having won in these classes. The Stud Dog or Brood Bitch must appear in the ring with the get or produce and be entered in the class. The owner of the Stud Dog or Brood Bitch does not need to be the owner of the get or produce.

**STUD DOG CLASS** - For Stud Dogs and at least two of their get. Get must be entered in one of the regular classes in this show. The award is based on the merits of the get.

**BROOD BITCH CLASS** - For Brood Bitches that have whelped two of their produce. Produce must be entered in one of the regular classes at this show. The award is based on the merits of the produce.

**BRACE CLASS** - For two Siberians with identical ownership. Both dogs must be entered in regular classes.

**TEAM CLASS** - For four Siberians with identical ownership. All dogs must be entered in regular classes.
